## ORDINANCE NO. 68

## ORDINANCE TO AMEND ORDINANCE NO. 60 OF THE TOWN OF MOUNT CARMEL, TENNESSEE

WHEREAS, Ordinance No. 60 was passed on the third reading on May 8, 1975, annexing to the Town of Mount Carmel, Tennessee a portion of the land known as Brookshire Hills-Wolfe Lane in accordance with authority conferred by Chapter 113 of the Public Acts of Tennessee, 1955, and;

WHEREAS, a proceeding was filed in the Chancery Court for Hawkins County, Tennessee, at Rogersville, being Civil Action No. 5740, which resulted in alteration of the boundaries of the parcel of land as described in Ordinance No. 60; and

WHEREAS, it appears that Ordinance No. 60, Section 1 should be amended to accurately reflect the description of the territory incorporated into the Town of Mount Carmel, Tennessee.

NOW, THEREFORE, BE IT ORDAINED by the Board of Mayor and Aldermen of the Town of Mount Carmel, Tennessee that Ordinance No. 60, Section 1 be amended to reflect the following described territory:

BEGINNING at a point, said point being in the northern most junction of the Mount Carmel-Church Hill corporate lines; thence from said point in a northerly direction following the Mount Carmel-Church Hill regional planning boundary line, and the Mount Carmel corporate line for a distance of approximately 10,900 feet to a point, said point being in the southerly right-of-way line of Carter's Valley Road and also being directly in front of the Old Grange Hall School; thence from said point in an easterly direction and following the southerly right-ofway line of Carter's Valley Road for approximately 6,880 feet to a point, said point being the intersection of Carter's Valley Road with the easterly right-of-way line of McCracken Lane; thence from said point in a southerly direction Extended and following said easterly right-of-way line of McCracken Lane for a distance of approximately 2,640 feet to a point, said point being the mid channel of Sensabaugh Branch; thence from said point in a westerly direction and following the mid channel of Sensabaugh Branch for a distance

of approximately 2,600 feet to a point, said point being approximately 200 feet northeasterly of Independence Avenue; thence from said point in a southeasterly direction and remaining 200 feet east of Independence Avenue for a distance of approximately 1,800 feet to a point, said point being the northeastern corporate boundary of Mount Carmel; thence from said point in a westerly direction and following the existing corporate boundary line to the point of BEGINNING.

Section 2. This ordinance shall be effective from and after its passage, the public welfare requiring it.
