

AN ORDINANCE TO ANNEX CERTAIN TERRITORY AND TO INCORPORATE SAME WITHIN THE CORPORATE BOUNDARIES OF THE TOWN OF MOUNT CARMEL, TENNESSEE.

WHEREAS, a public hearing before this body was held on the 14th day of March, 1985, pursuant to a resolution adopted on January 10, 1985, and notice thereof published in Post-News on 3-6-85; and,

WHEREAS, it now appears that the prosperity of this town and of the territory herein described will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered if such territory is not annexed; and,

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the residents and property owners thereof and of this town as a whole; and

WHEREAS, a plan of service for this area was adopted by resolution on March 14, 1985 as required by section TCA 51-10 Tennessee Code Annotated;

NOW, THEREFORE, Be it ordained by the Board of Mayor and Aldermen of the town of Mount Carmel, Tennessee:

Section 1. Pursuant to authority conferred by sections Tennessee Code Annotated, there is hereby annexed to the town of Mount Carmel, Tennessee, and incorporated within the corporate boundaries thereof, the following described territory adjoining the present corporate boundaries:

Embracing that certain part of civil district no. 7 of Hawkins County, Tennessee, and more fully described, to-wit:

BEGINNING at a point, said point being in the north westerly corporate boundary of Mount Carmel on Loyd Chapel Road, thence in a westerly and southerly direction 500 feet north and paralleling the existing Loyd Chapel Road right of way encompassing Hermitage Hills subdivision and the Glen O. Tester residence for a distance of approximately 5000 feet, to a point said point being the western boundary of the Glen O. Tester property, thence in a southerly direction paralleling the Glen O. Tester western property boundary, to a point said point being the south westerly boundary of the Glen O. Tester property at the boundary of Ivon "Pete" Loyd property, thence in an easterly and northerly direction paralleling the northern boundary of the Ivan "Pete" Loyd property for a distance of approximately 1000 feet to a point, said point being the north east corner of the Ivan "Pete" Loyd Property, thence in a southerly direction paralleling the the easterly boundary of the Ivan "Pete" Loyd to a point, said point being 500 feet south of the existing southern boundary of Loyds Chapel Road, thence from said point in an easterly direction paralleling the Loyd Chapel Road. for approximately 4500 feet to a point, said point being 500 feet south of the Loyd Chapel Road right of way at the existing corporate boundary of Mount Carmel, thence in a northerly direction for approximately 1040 feet to point of BEGINNING.

Section 2. This ordinance shall be effective from and after its passage, the public welfare requiring it.
