### **ORDINANCE NO. 252**

AN ORDINANCE AMENDING TITLE 14, "ZONING AND LAND USE CONTROL", CHAPTER 6, "GENERAL PROVISIONS," SECTION 14-606, "STREET FRONTAGE."

WHEREAS, the Board of Mayor and Aldermen of the Town of Mount Carmel desires to create uniformity in its subdivision regulations and zoning ordinance; and

WHEREAS, the Mount Carmel Regional Planning Commission has recommended at its June 11, 2002, meeting the following amendment; and

WHEREAS, the public welfare requiring it.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF The Town of Mount Carmel, Tennessee, as follows:

**SECTION I.** that the Mount Carmel Municipal Code Title 14, Chapter 6, Section 14-606, be deleted in its entirety and in its place the following section substituted:

14-606. STREET FRONTAGE. No residential building shall be erected on a lot which does not abut at least one public street for at least fifty (50) feet except for lots on cul-de-sacs and flag lots which must abut one public street for at least forty (40) feet.

#### SECTION II. LEGAL STATUS PROVISIONS.

- A. <u>Conflict With Other Ordinances</u>. In case of conflict between this ordinance or any part thereof, and the whole or part of any existing or future ordinance of the Town of Mount Carmel, the most restrictive shall in all cases apply.
- B. <u>Validity</u>. If any section, clause, provision or portion of this ordinance shall be held to be in doubt or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, provision, or portion of this ordinance which is not of itself invalid or unconstitutional.
- C. <u>Effective Date</u>. This Ordinance shall become effective upon passage and publication, the public welfare requiring it.
