ORDINANCE NO. 382

AN ORDINANCE TO REPEAL ORDINANCE No. 11-368 AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE

- **WHEREAS**, the Town adopted its Ordinance No. 11-368 relating to *Synthetic Marijuana*, "Bath Salts" and Similar Compounds; and,
- WHEREAS, pursuant to *Tenn. Code Ann. § 16-18-302(a)(2)*, a municipal court possesses jurisdiction to enforce any municipal ordinance that mirrors, substantially duplicates or incorporates by cross-reference the language of a state criminal statute, if and only if the state criminal statute mirrored, duplicated or cross-referenced is a Class C misdemeanor; and,
- WHEREAS, 2012 Tennessee Public Chapters 838, 843 and 848, relative to controlled substance analogues, imitation controlled substances and controlled and illegal substances makes the activities proscribed by Ordinance No. 11-368 a felony, thereby depriving the municipal court of jurisdiction over such matters. Now therefore,

BE IT ORDAINED by the Board of Mayor and Aldermen as follows:

- SECTION I. That Ordinance 11-368 relating to *Synthetic Marijuana*, "Bath Salts" and Similar Compounds is hereby repealed in its entirety.
- SECTION II. That this ordinance shall take effect from and after its date of passage, as the law directs, the public welfare of the Town of Mount Carmel demanding it.
