ORDINANCE NO. 13-389

AN ORDINANCE REPEALING THE HOURS OF SALE FOR BEER.

WHEREAS, Section 8-217(2) of Title 8 "Alcoholic Beverages", Chapter 2 of the Municipal Code regulates the hours of sale of beer; and

WHEREAS, State Regulations require that upon approval of liquor by the drink, the hours of sale for beer shall coincide with the hours of sale for liquor by the drink, such hours being regulated by the State Alcoholic Beverage Commission;

WHEREAS, the public health and welfare require it;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, as follows:

SECTION I. Section 8-217(2) of Title 8, Chapter 2 of the Municipal Code is

repealed in its entirety.

SECTION II. This Ordinance shall take effect from and after the date of its

passage and publication, as the law directs, the public welfare of

the town of Mount Carmel, Tennessee, requiring it.
