NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN FOR THE TOWN OF MOUNT CARMEL, TENNESSEE THAT CHANGES BE MADE TO THE TO AMEND THE ORDER OF BUSINESS AT THE BOARD OF MAYOR AND ALDERMEN MEETING OF THE TOWN OF MOUNT CARMEL, TENNESSEE AS FOLLOWS:

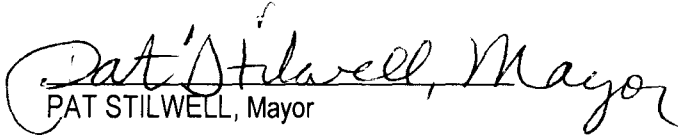
SECTION 1. That the Code of Ordinances, Title 1, "General Administration," Chapter 1, "Board of Mayor and Aldermen," Section 1-102, relating to the Order of business at the Board of Mayor and Aldermen meeting, is hereby amended to read as follows:

1-102. Order of Business. At each meeting of the Board of Mayor and Aldermen, the following regular order of business shall be observed unless dispensed with a majority vote of the members present:

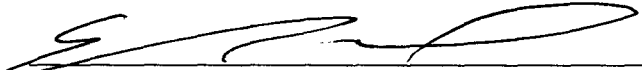
1. Call to Order
2. Prayer
3. Pledge of Allegiance
4. Roll Call
5. Welcome from the Mayor
6. Approval and/or Correction of the Minutes/ Department and Committee Written Reports
7. Old Business
8. New Business
9. Visitor Comments
10. Mayor Comments
11. City Administrator Comments
12. Aldermen Comments
13. Attorney Comments
14. Adjournment

SECTION II. Under Visitor Comments, any persons wishing to address the Board shall stand and state your name and address and shall be limited to a 5-minute presentation. The Board may NOT participate in any discussion and cannot vote on the subject you present.

This Ordinance shall take effect immediately upon final passage.

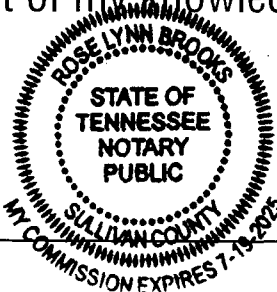
