

RESOLUTION NO. 281

RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, APPOINTING A REPRESENTATIVE TO THE HAWKINS COUNTY REGIONAL SOLID WASTE PLANNING BOARD.

WHEREAS, Tenn. Code Anno. §68-211-813 requires that each municipality that provides waste collection and/or disposal services designate a representative to the regional board. This board being the Hawkins County Solid Waste Planning Board; and

WHEREAS, Gary Lawson, presently serves as the designated representative for the Town of Mount Carmel. His term will expire on April 30, 2003; and

WHEREAS, re-appointment or replacement must be considered for recommendation to the Hawkins County Commission; and

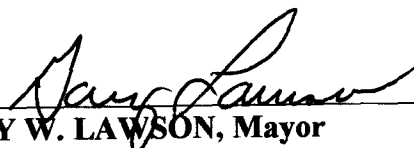
WHEREAS, the public welfare requires it.

Section I. That Gary Lawson be re-appointed to the Hawkins County Regional Solid Waste Planning Board as the representative for the Town of Mount Carmel, Tennessee, for a term of six (6) years, ending April 30, 2009.

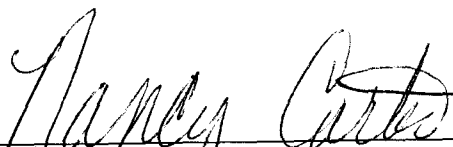
Section II. This Resolution shall take effect upon its passage the public welfare requiring it.

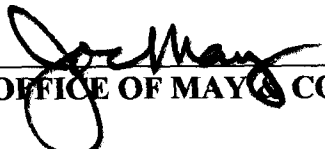
