

RESOLUTION NO. 306

A RESOLUTION AMENDING THE SCHEDULE OF FEES AND RATES AS OF DECEMBER 28, 2004.

WHEREAS, the monetary amount of all fees or charges levied or assessed in the code of ordinances shall be established by the Board of Mayor and Alderman as the necessity or advisability of same may from time to time require.

BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMAN as follows:

That the following fee and rate schedule is hereby adopted.

Building Permits

Base fee: \$ 20.00

Residential Construction (single family): \$0.10 per square foot of living space plus
(Includes houses, garages, additions and \$35.00 per inspection
remodeling to create living space from garages
and/or basements/attics): (minimum 4 new houses)

Residential single family remodeling: \$20.00 plus \$35.00 per inspection
(Decks, retaining walls, porches, replacement
windows, structural changes/repairs)

Multi-family residential and other business/commercial/industrial

Fees will be based on the estimated cost/valuation of the project as follows:

\$1,000 and less

\$20.00 plus \$35.00 per inspection.

\$1,000 to 50,000

\$20.00 for the first \$1,000 plus \$5.00 for
each additional thousand or fraction thereof,
to and including \$50,000 plus \$35 per
inspection (minimum of 10).

\$50,000 to \$100,000

\$265.00 for the first \$50,000 plus \$4.00 for
each additional thousand or fraction thereof,
to and including \$100,000 plus \$30.00 per
inspection (minimum of 10).

\$100,000 to \$500,000

\$465.00 for the first \$100,000 plus \$3.00 for
each additional thousand or fraction thereof,
to and including \$500,000 plus \$35.00 per
inspection (minimum of 10).

\$500,000 and up

\$1,660.00 for the first \$500,000 plus \$2.00
for each additional thousand or fraction
thereof plus \$35.00 per inspection (minimum
of 10).

Moving Fee:

\$100.00 For the moving of any building or
structure

Demolition Fee:

\$100.00 For the demolition of any building or
structure

Building Permit Penalties:

Where work for which a permit is required by code is started or proceeded prior to obtaining said permit, the fees herein specified shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of code in the execution of the work nor from any other penalties prescribed.

Refunds:

Building permit fees, less the base fee, may be refunded if a.) the permit is denied, or b.) the project is canceled provided that: no work has commenced, no inspection has taken place, and that application is made to the Treasurer within six (6) months of the application for building permit date.

Development/Planning/Stormwater/Floodplain fees:

Stormwater basins	\$100.00 each plus \$100.00 per inspection (minimum of 1).
Development fees for subdivisions	\$500.00 minimum charge for each phase of the subdivision plus \$50.00 for each lot over 10.
Development fees for single family residential (new construction only)	\$0.10 per square foot of living space
Development fees for multi-family residential commercial/industrial (new construction only)	\$0.30 per square foot (net usable space)
Driveway/curb cut fee	\$30.00
Grading permit:	
Restricted	\$150.00
Unrestricted	\$50.00
Planning commission:	
Variances/appeals	\$50.00
Special called meeting fee	\$50.00
Floodplain plan review fee	\$100.00

Mud/Silt/Debris Prevention, Clean-up, Repair Fees, per incident:

Service charge; and	\$100.00
Administrative fee, and cost of any materials used; and	\$250.00

The Cost of Equipment and Personnel Computed as Follows:

Backhoe and/or Bobcat with operator	\$50.00 per hour, 2 hour minimum
Dump truck with operator	\$35.00 per hour, 2 hour minimum
Pickup truck with operator	\$25.00 per hour, 2 hour minimum
Fire truck with crew	\$100.00 per hour, 2 hour minimum
Supervisory personnel	\$35.00 per hour, 2 hour minimum
Laborers	\$22.50 per hour, 2 hour minimum

The above costs will be at 1½ times the above for after hours/weekend/holiday work.

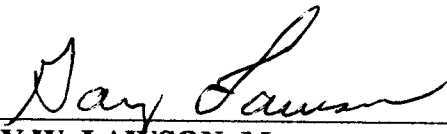

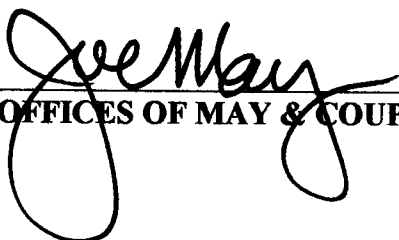
