WHEREAS, the above-mentioned fire equipment is no longer needed by the Mount Carmel Fire Department; and

WHEREAS, the Stanley Valley Volunteer Fire Department has helped the Town of Mount Carmel in the past by providing a 1977 Ford tanker truck for use by our Volunteer Fire Department and they have requested the above-mentioned fire equipment for their use if it is declared as surplus property.

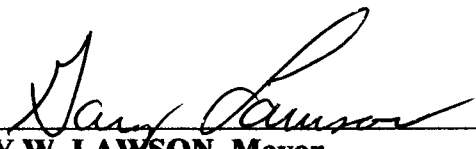

SECTION I. The Board of Mayor and Aldermen hereby declare the said fire equipment as surplus property.

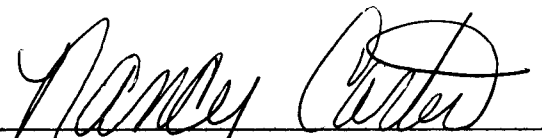
SECTION II. The Board of Mayor and Aldermen hereby authorizes the donation of the fire equipment to the Stanley Valley Volunteer Fire Department.
