A RESOLUTION TO DECLARE CERTAIN FIRE EQUIPMENT SURPLUS PROPERTY AND DONATE SAID PROPERTY TO THE STANLEY VALLEY VOLUNTEER FIRE DEPARTMENT.

WHEREAS, the Town of Mount Carmel has in its inventory certain fire equipment, four (4) Survive air bottles and one (1) Scott air pack; and

WHEREAS, the above-mentioned fire equipment is no longer needed by the Mount Carmel Fire Department; and

WHEREAS, the Stanley Valley Volunteer Fire Department has helped the Town of Mount Carmel in the past by providing a 1977 Ford tanker truck for use by our Volunteer Fire Department and they have requested the above-mentioned fire equipment for their use if it is declared as surplus property.

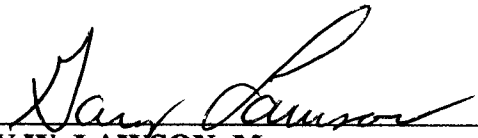
