A RESOLUTION DETERMINING THAT A NEED FOR A HOUSING AUTHORITY EXISTS AND APPOINTING COMMISSIONERS FOR THE MOUNT CARMEL HOUSING AUTHORITY

- WHEREAS, pursuant to Section 4-101 of the Municipal Code relating to the creation of a Housing Authority, twenty-five (25) residents of the Town of Mount Carmel have filed the attached petition with the Recorder setting forth that there is a need for a Housing Authority to function in the Town; and,
- WHEREAS, the Recorder has caused notice to be published in the Kingsport Times-News on May 9, 2006, of the time, place, and purposes of a public hearing at which the Board of Mayor and Aldermen will determine the need for an authority in the Town; and,
- WHEREAS, pursuant to said notice, an opportunity to be heard was granted to all residents and taxpayers of the Town and the surrounding area and to all other interested persons. Now Therefore,

BE IT RESOLVED that the Board of Mayor and Aldermen having taken into consideration the criteria set forth in Section 4-102 of the Municipal Code relating to the creation of a Housing Authority, does hereby determine that unsanitary or unsafe inhabited dwelling accommodations exist in the Town and the surrounding area; and, that there is a lack of safe or sanitary dwelling accommodations in the Town and the surrounding area available for all the inhabitants of the Town of Mount Carmel or area; and,

BE IT FURTHER RESOLVED that the above enumerated conditions having been found to exist, the Board of Mayor and Aldermen hereby gives notice of such determination to the Mayor; and,

BE IT FURTHER RESOLVED that the Mayor hereby appoints the following five (5) commissioners to act as an authority:
