WHEREAS, the Governor's Highway Safety Office seeks to encourage communication between the Department of Safety and local departments by providing pertinent information through the Integrated Criminal Justice Web Portal; and

WHEREAS, the Town of Mount Carmel now seeks to participate in this important program; and

WHEREAS, the public welfare requires it;

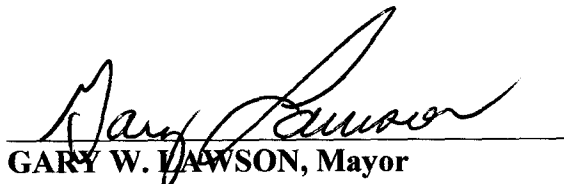
NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, as follows:

Section I. That the Town of Mount Carmel is hereby authorized to apply and accept a Governor's Highway Safety Office Integrated Criminal Justice Web Portal Access Fee Grant which pays the access fee for the Mount Carmel Police Department during the current federal fiscal year and upon award appropriately budget for its use; and

Section II. The Mayor shall do all things necessary to validate and make the agreement legally binding including, but not limited to, affixing his or his designee's signature thereto; and

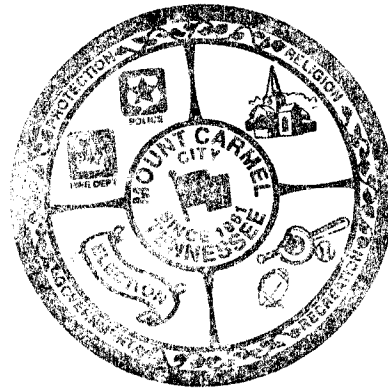
Section III. This Resolution shall take effect upon its passage the public welfare requiring it.

**Memorandum of Understanding between Integrated Criminal Justice
Program (ICJP) and Agencies with access to the ICJ Web Portal**

This agreement is between Integrated Criminal Justice Program (ICJP) and

THE MOUNT CARMEL POLICE DEPT. (AGENCY).

PURPOSE

The ICJP has obtained a one-year grant through the Governor's Highway Safety Office (GHSO). The purpose of this grant is to pay the annual Criminal Justice Web Portal access fee for each current or new local or state agency that will be provided access during the current federal fiscal year October 1, 2009 through September 30, 2010.

The ICJP agrees to pay the access fee due during the current federal fiscal year. Payment will be made on the anniversary date of the agency's Criminal Justice Web Portal account. Subsequent billings that may occur (due to an increase in the number of users within the agency) during this same time period will also be payable under the GHSO grant.

TERM OF AGREEMENT

This agreement shall terminate on September 30, 2010. Any annual Criminal Justice Web Portal access fees due and payable after this date will be the responsibility of the AGENCY.
