WHEREAS, the Rural Development Library Grant can be used to purchase computer equipment; and

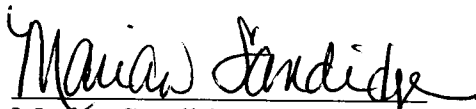
WHEREAS, the estimated cost of the project is \$13,613, with proposed funding to come from the Rural Development Library Grant.

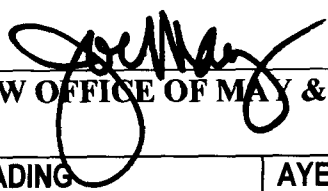

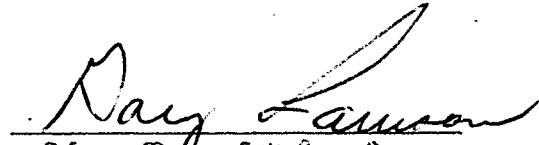

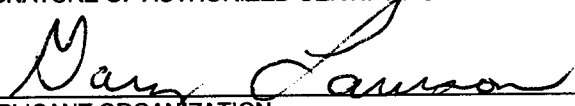
