Mount Carmel donates truck for Stanley Valley VFD 'Elderly Assist' program

MOUNT CARMEL — Stanley Valley firefighters will be using a "new" used 2000 Ford Expedition contributed by the town of Mount Carmel to continue the department's "Elderly Assist" program.

On Tuesday, the Mount Carmel Board of Mayor and Aldermen voted 7-0 in favor of donating the Expedition to the Stanley Volunteer Fire Department.

SVVFD Chief Stacy Vaughan, who attended Tuesday's BMA meeting, said the Elderly Assist program is currently in its second year.

"We had a lot of elderly people in our community that we as a fire department took it upon ourselves to go out and routinely check on them," Vaughan told the BMA. "We make sure they have food, they have heat sources or if they need fuel for their heaters. We've been using our personal vehicle to do that instead of using a fire truck."

Vaughan noted that the SVVFD operates on \$30,000 and most of its funds go toward maintaining fire trucks and training. He said the department wouldn't be able to afford another vehicle for the Elderly Assist program.

Vaughan added, "This vehicle, along with serving in that program, would be a vehicle that my members could use, travel to and from training. It will be a vehicle they can use without using their own."

Alderman Frances Frost noted that the vehicle was received by the town as military surplus and wasn't purchased with local funds.

Mayor Larry Frost said the legality of donating military surplus equipment was confirmed.

In other business Tuesday the BMA:

- *Heard a report from Frost that the town will be applying for a \$500,000 Community Development Block Grant to pay for improvements to the sewer treatment plant. Frost said that once the sewer plant upgrade is completed, "The sewer plant will be up to par to handle anything that comes in here any kind of development we have if we get this grant right here."
- *Accepted a low bid of \$17,644 from Snograss Carpentry of Church Hill for the roof, insulation and guttering project at the public works building.

Frost noted that the low bid was \$600 over budget, but he said re-advertising would cost another \$300. The only other bid was more than \$22,000.

The board agreed to move forward with the current low bid.

- *Heard a report from Johnny Castle, public works director, that the citywide paving project will start Nov. 4, weather permitting.
- *Declared several items a surplus, including a 2004 Ford Crown Victoria, a 2000 Ford Crown Victoria, a 2006 Ford Expedition, seven prisoner partitions for Crown Victorias and six push bumpers for Crown Victorias all of which were purchased originally from the general fund.
- *Heard a report from Frost that a new Blimpies sub sandwich shop will be opening on Main Street around the first of November next to the Rub-A-Dub Car Wash.
- *Heard a report from Police Chief Mike Campbell that there is enough money in the drug fund to purchase a new patrol car and equip that car with state safety grant funds. The total cost will be about \$30,000 at no cost to the town.
