RESOLUTION ESTABLISHING MOUNT CARMEL SENIOR CITIZENS COMMITTEE

WHEREAS, on February 24, 2015, at the regular meeting of the Mount Carmel Board of Mayor and Aldermen, a motion was made by Alderman Paul Hale to take over the supervision and operation of the Senior Citizens Center, to assure its financial stability; and

WHEREAS, by majority vote, Alderman Hale's motion was approved;

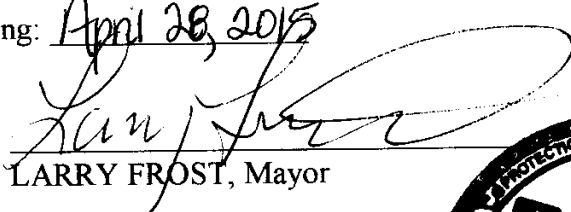
NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, that a committee, the membership of which shall be appointed by Mayor Larry Frost, shall be formed to carry out the motion proposed by Alderman Hale. Said committee shall be named the Mount Carmel Senior Citizens Committee, and it shall advise the Mount Carmel Board of Mayor and Aldermen on the steps to be taken to create a new Mount Carmel Senior Citizens Center, including securing grants, funding issues, soliciting and hiring a director, and other business to be undertaken in the formation of the Mount Carmel Senior Citizens Center. This committee shall be comprised of five members, who shall select a Chairman, and upon formation, shall develop a plan for implementation of the new Mount Carmel Senior Citizens Center. This committee shall continue to operate until a director is hired, at which time the committee shall be disbanded.

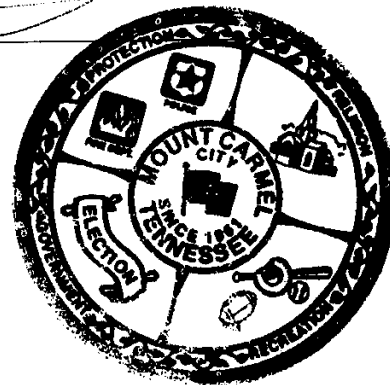

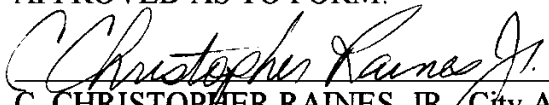
