A RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE APPOINTING GARRETT WHITE TO FILL THE UNEXPIRED ALDERMANIC TERM OF P.E. DIANE ADAMS.

- WHEREAS, Alderman P.E. Diane Adams has submitted her resignation from the Town of Mount Carmel Board of Mayor and Aldermen; and
- WHEREAS, the Town of Mount Carmel Board of Mayor and Aldermen has adopted a Resolution to accept the resignation of P.E. Diane Adams from the Board of Mayor and Aldermen; and
- WHEREAS, the Town of Mount Carmel City Charter requires the Board of Mayor and Aldermen to appoint a qualified citizen to fill the aldermanic vacancy created by P.E. Diane Adams' resignation, and that such appointee shall serve the remainder of the vacant term of office or until the next regular general election, whichever shall occur first; and
- WHEREAS, P.E. Diane Adams' term of office was scheduled to expire with the election scheduled for November 6, 2018, and the next regularly scheduled general election is scheduled for November 6, 2018; and
- **WHEREAS,** Garrett White of 421 Old Hickory Circle in Mount Carmel, has agreed to fill the Aldermanic vacancy created by P.E. Adams' resignation.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF MOUNT CARMEL, TENNESSEE, as follows:

- **SECTION I.** Appointment to the Board of Mayor and Aldermen. Garrett White is hereby appointed to the position of Alderman in the Town of Mount Carmel, Tennessee.
- SECTION II. Term of Office. Pursuant to the Town Charter, Garrett White shall serve as Alderman until the next regular general election, scheduled for November 6, 2018, and until his successor to office has been elected and qualified.
- **SECTION III. Effective Date.** This Resolution shall be in full force and effect from and after its date of passage by the Board of Mayor and Aldermen of the Town of Mount Carmel.
